

Villa Park Mariners Swim Team Swimsuit Policy

For the 2010 swim season, our team swimsuit is the **Tyr Eternal Flame**. This has a racer 'maxback' for the girls, and is available in the jammer style for boys. The Villa Park Mariners Swim Team does not require any swimmer to purchase the team suit. However, it is recommended that swimmers wear one-piece competition style (tight fitting) swimsuits for the meets. If you decide not to purchase a swimsuit through the team, similar suits are available at most sporting goods stores. Please keep in mind that the team color is royal blue.

VP Mariners Parent's Association will provide one latex team cap to each female swimmer and to male swimmers upon request. Caps are required in most pools, including Villa Park, if hair is long. Earplugs, goggles, and nose clips are optional but may be recommended by the coach, although goggles are highly recommended.

If you wish to purchase a team suit, please fill out the form below, and return it with payment to Lori McNamara on or before Friday, May 21, 2010. We expect suits to be delivered in time for the first meet, but cannot control the delivery process. **ONLY ONE DISCOUNTED SUIT PER SWIMMERS REGISTERED ON OR BEFORE THE EARLY BIRD DEADLINE.**

Sizing Tips: Measure waist about 1" below the natural waist or just above the hipbone. For competition follow the chart below for correct size. LYCRA SUITS STRETCH IN THE WATER WITH REPEATED USE. The fit should be tight. **We are not responsible for excessive bagginess if you oversize your swimmer.**
